## OBJETIVOS

The processes of globalisation and the metamorphosis of English as the lingua franca of international trade have meant that both the legal and international relations sectors now require a labour force with a high level of linguistic competence in professional English. International certification in the area of legal English also demands highly specialized and individualized training. UVEG's International Legal English Diploma (ILEX) aims to fill the existing void in the teaching of the type of language a lawyer needs, in order to develop strong professional skills in the main areas of legal English: civil law, commercial law, banking and finance law, competition law, transnational law, real estate law, IPL, etc. In addition, ILEX will help prepare for the international certification TOLES (Test of Legal English Skills, International Division of the Law Society of England and Wales) a test recognized as proof of legal English skills by the major law firms, corporations, and international organizations. ILEX is also particularly valuable for Master's (and final-year) students, who meet admission requirements, in the areas of law, economy, translation and English studies. Finally, this postgraduate degree will also prove instrumental for those preparing for the English language tests in competitions launched by the Central State Administration, Regional Governments, Local Administrations, Autonomous Agencies, European Union, etc.

## METODOLOGÍA

ILEX is a blended learning degree, taught online with one monthly face-to-face class meeting (on Friday evening 4-8 pm) and a face-to-face examination at the end of each subject. Lectures and study aids will be recorded and permanently available online, and weekly tasks will also be uploaded, corrected by the instructors and sent back to students on a weekly basis. The face-to-face class meeting will be devoted to a review of the key aspects of each subject's units, to a Q&A session, and to the completion and correction of a mock test, in preparation for the final test. We will be practicing all four basic skills (reading, writing, listening and speaking) and the textbook will be: Krois-Lindner, Amy & TransLegal 2011: International Legal English, 2nd edition, Cambridge: Cambridge University Press. We will also upload materials and practice papers from TOLES Higher and Advanced to our virtual classroom.

Attendance and participation amount to 50% of the final grade; final tests determine the other 50% of the final grade. There will be two calls for each subject, one at the end of each teaching period, and another one at the end of the academic year; 2nd call make-up tests for all subjects will take place in June 2020.
